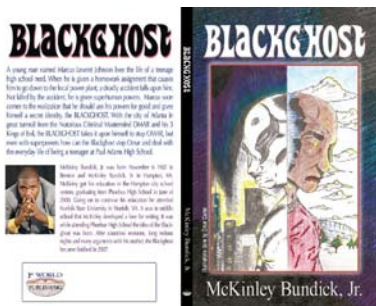

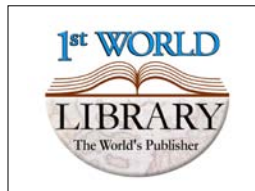

STROKE



I think it would be safe to say everyone has had a family member or know of someone who has suffered from a stroke. I think it is important that we should have a general understanding of what actually entails a stroke. A stroke is when an area of the brain is deprived of blood supply long enough to cause brain tissue to die. The same scenario occurs in the events leading to a heart attack. The blood carries oxygen to the cells in the brain and with the lack of oxygen, the cells die and a cascade of events follow that may lead to paralysis and even death.

Strokes kill over 143,000 people each year. It is the # 3 cause of death in the United States. Over 800,000 people suffered from strokes last year and roughly a stroke occurs every forty seconds.

The causes of strokes may entail a) arteries (vessels that carry oxygen-rich blood) that have become narrowed, stiffen due to atherosclerosis, plaque development due to cholesterol that do not allow blood flow to the brain, b) aneurysm which is a weakened spot on the artery that bursts and causes bleeding into the brain, and c) atrial fibrillation or an abnormal heart beat to the upper chambers of the heart that produces a blood clot that travels to the brain and prevents blood supply past the point of obstruction.

Medical conditions that increase the risks of stroke include high blood pressure, diabetes which doubles the risks of a stroke, and heart problems such as heart attack, congestive heart failure, atrial fibrillation as alluded above. It is important that you and your doctor maintain adequate blood pressure control and proper glucose (sugar) levels. Lifestyle modifications that may reduce the risk of stroke include smoking cessation, diet modification or reduction in salt and fatty foods, alcohol consumption, and inactivity or "couch potato".

There are certain factors that cannot be controlled. They include race or ethnic background; African Americans are at a higher risk than Caucasians. The stroke death rate for 2005 showed blacks at 70 per 100,000 compared to whites 44 per 100,000. Other factors include Age – more common in individuals over 55, sex or gender – males more common than females, and hereditary – first-degree relative who had a stroke before age 50 are at a higher risk of developing a stroke.

The main aim of treating a stroke is to act fast to save the brain tissue by restoring the blood flow and if possible the cells to recover. So it is important to be knowledgeable of stroke and to activate the emergency medical system to improve the outcome. You should be aware certain hospitals are designated stroke centers and these facilities are better equipped to manage such emergencies.

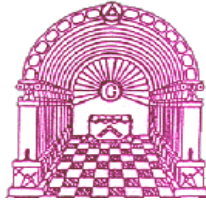

"A GLIMPSE INTO HISTORY"

Operating under authority of the United Supreme Council 33°, A.A.S.R. of Freemasonry P.H.A., Southern Jurisdiction, United States of America, the Virginia Council of Deliberation (VCOD) exercises supervision over 9 consistories in the State of Virginia. Each Consistory has 3 subordinate houses called Councils of Kadosh, Chapters of the Rose Croix and Lodges of Perfection. Being organized to promote Scottish Rite Masonry of the 4th through 32nd Degrees and to foster charitable endeavors, the VCOD and its Consistories have sponsored blood drives, given assistance to the needy, contributed to disaster relief and scholarship programs.

Sovereign Grand Inspector General George M. Ellis, Jr. 33° of Petersburg Consistory #144 provides leadership and supervision over the VCOD and Its constituent Consistories. As Illustrious Deputy of the Orient, he is the Supreme Council's representative for Scottish Rite Masons in the State. In the past, it was generally held that the Rev. Bishop (SGIG) Howard Z. Plummer, 33° was the first Deputy for the State of Virginia, but recently it was discovered that SGIG John W. Barnes held that honor. Therefore, since its inception in 1924, stewardship over the VCOD has been exercised by SGIG John Henry Evans, Jr., SGIG Richard L. Jones, and SGIG George M. Ellis, Jr.

Other Scottish Rite Masons of VA who attained the title of Sovereign Grand Inspector General, 33°, include SGIG Roswell A. Taylor, Sr., who served as Budget Committee Chairman for the Supreme Council, SGIG Gilbert S. Reddings who currently serves as Illustrious Grand Treasurer-General, H.E., and SGIG Michael A. Parris, a member of the Finance and Investments Committee. It should be noted that GIG Andre' F. Samuel, Sr., and GIG Alan Thornton also served as Grand Recorders for the Supreme Council and that the late Thurgood Marshall, 33°, a U.S. Supreme Court justice, was a member of the Orient of Virginia.

The VCOD currently has 1,002 Sublime princes on its rolls, 235 are General Inspector Generals, 33°, and four are Sovereign Grand Inspector Generals, 33°. Whereas, Consistories and their subordinate houses confer the 4th through 32nd Degree on eligible Scottish Rite Masons, the Supreme Council confers the 33rd Degree on deserving nominees who are selected from the ranks of Sublimes Princes. We are proud to report that at the 122nd Annual Session of the Supreme Council, held in Tulsa, Oklahoma on October 10 through 13 2008, thirteen Sublime Princes from Virginia from Virginia were coroneted as Grand Inspector General 33rd Degree. They are as follows: MW Grand Master Larry D. Christian, #22, RW Deputy Grand Master Herman G. Eggleston, J. #105, RW Senior Grand Warden Shelton Riddick #9, RW Senior Grand Deacon Paige Cherry #9, Ill Kenneth Samuels #22, Ill. George C. Hundley #40, Ill. James Fudd #156, Ill. Steven Legette #346, Ill. Paul L.R. White #346, and Ill. Larry Miller #9
